Every four years, the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) are required to review the metropolitan transportation planning process conducted by the Southeastern Massachusetts Metropolitan Planning Organization (SMMPO), Massachusetts Department of Transportation (MassDOT), Greater Attleboro Regional Transit Authority (GATRA), Southeastern Regional Transit Authority (STRA), and their local municipal partners in order to certify that they are carrying out the process in accordance with all applicable Federal requirements.

As part of this review, the Federal agencies would like to hear from members of the public on their views of how the metropolitan transportation planning process is conducted in the region.
