5. Election of Officers and Executive Committee: Ms. Alfaro, Chair of the Nominating Committee referred Members to page 7 of the Commission meeting packet. She mentioned the Nominating Committee met on June 23, 2025 and presented the slate of officers for the 2025-2026 term. She indicated that Mr. David Wojnar had recently been appointed as a Select Board representative in lieu of James Kennedy, with paperwork on the way, and also available to fill Mr. Kennedy's seat on the Executive Committee.

6. Reports:

- a. Vice Chair: No report.
- b. **Executive Director**: Mr. Walker reported that the Senate budget had included District Local Technical Assistance funding at \$4 million this year, a one million dollar increase over previous years, which is fantastic news, and that it is hoped the additional monies which have proven invaluable in responding to key local planning needs makes it into the final budget.

Chairwoman Clarner thanked all of the returning Commissioners and the new Commissioner for offering up their time and expertise to enable the southeast region to continue to be the amazing place that it is.

7. Consent Agenda:

a. **Contracts:** Chairwoman Clarner referred Commissioners to the contracts listed in the packet and read each contract for approval

Be it resolved that the SRPEDD Commission authorizes the Chairman, Treasurer, Officers, and Executive Director, as appropriate, to negotiate and execute the following contracts:

- 1. With the Massachusetts Gaming Commission to create the *Plainridge Park Regional Mobility Network Analysis* in the communities surrounding Plainridge Park Casino for an amount not to exceed \$235,000.
- 2. With the Town of Middleborough to create and Active Shooter and Hostile Event (ASHE) Response Tool Kit for an amount not to exceed \$53,881.

A motion was made and seconded to approve the contracts listed above and as read. VOTED UNANIMOUSLY.

8. Committee Reports:

a. **Finance Committee:** Mr. Hills mentioned the Finance Committee met on June 18, 2025, at SRPEDD - 88 Broadway. The May 21, 2025, Finance meeting minutes were approved. The Treasurer's Report for May 2025 was received, and a warrant for expenses signed-off on in the amount of \$481,492.05. Lastly, the Committee reviewed and approved the May 2025 Month-End General Journal entries. Mr. Walker mentioned SRPEDD is making some good strides with respect to enhanced financial reporting and dashboard-style outputs, capitalizing more fully on our financial software platform thanks to Mr. Horowitz's coding and systems expertise, with further updates to follow.

A motion was made and seconded to approve the Finance Committee report. VOTED UNANIMOUSLY.

b. Joint Transportation Planning Group/MPO: Ms. Estrela-Pedro presented the JTPG and SMMPO report with the minutes starting on page 10 of the meeting packet. She mentioned the JTPG met on May 14th and the SMMPO met on May 20th. She highlighted that at these meetings the Complete Streets Program was discussed with information for communities on how to participate. The Transportation Improvement Program for FFY 26 to 30 was endorsed at the MPO meeting on the 20th and Unified Planning Work Program for FFY 26 released for a 21-day comment period. Ms. Estrela-Pedro indicated if anyone had additional questions to please reach out to her.

A motion was made and seconded to approve the Transportation report. VOTED UNANIMOUSLY.

- **2025 SMMPO Election:** Ms. Estrela-Pedro mentioned there are two seats that are available for Carver and Westport that are going to be expiring at the end of July. She mentioned she has four votes to come before the Members.
 - Vote to Nominate Plymouth/Norfolk Candidate Sarah Hewins, Carver: Ms. Estrela-Pedro mentioned the Plymouth/Norfolk seat was available and that Ms. Hewins from Carver was on the Zoom meeting. She introduced Ms. Hewins and referred Members to her resume and background information on page 28. Ms. Hewins stated that she has been on SMMPO for a couple of years now and in her town has served on the Planning Board for 10 years and been a Conservation Agent for 15. She also has been on the Select Board for 16 years. Ms. Estrela-Pedro mentioned she is a great asset and asks a lot of great questions.

A motion was made and seconded to nominate Sarah Hewins as the Plymouth/Norfolk County representative to the SMMPO. VOTED UNANIMOUSLY.

 Vote to Nominate Bristol Candidate – Jennifer Vincent, Berkley & Manual Soares, Westport: Ms. Estrela-Pedro mentioned for the Bristol County seat she has two candidates who are Jennifer Vincent from Berkley and Manuel Soares of Westport. She referred Members to page 34 with Ms. Vincent's resume and mentioned she did not receive any paperwork from Mr. Soares. Neither unfortunately was able to attend to share a few words.

A motion was made and seconded to nominate Jennifer Vincent as the Bristol County representative to the SMMPO. VOTED UNANIMOUSLY.

 Vote to allow Andrew Romano to fill Andrew Saunders Vacancy: Next, Ms. Estrela-Pedro mentioned that she needs a vote to allow Andrew Romano fill Andrew Saunders' vacancy on the SMMPO. She mentioned his resume could be found on page 36.

A motion was made and seconded to allow Andrew Romano to fill Andrew Saunders vacancy on the SMMPO. VOTED UNANIMOUSLY.

 Vote to allow Michael Feck to fill Diana Bren's Vacancy: Lastly, Ms. Estrela-Pedro mentioned that she needs a vote to allow Michael Feck to fill Diana Bren's vacancy on the SMMPO.

A motion was made and seconded to allow Michael Feck to fill Diana Bren's Vacancy on the SMMPO. VOTED UNANIMOUSLY.

9. Programs and Project Updates:

- a. Interactive Transit Accessible Packland (ITAP) map: Mr. Brogan presented the Interactive Transit-Accessible Parkfinder Map (ITAP Map). The map highlights area parks that are within a half mile of bus stops for SRTA and GATRA. It also enables users to filter for specific services and facilities located at each park throughout the SRPEDD region. Some of the facilities include ADA-inclusive playgrounds, free summer lunches, splash pads, bike parking, restrooms, swimming, and athletic facilities, among other services. This is a "living map," where people provide feedback and recommendations in order to make this map even more responsive to the needs and aspirations of community members within the region. Mr. Brogan entertained questions from the Members who in turn thanked Mr. Brogan and mentioned that the ITAP map was a great tool.
- b. **Environmental Subcommittee Report (inclusive of MEPA report):** Ms. Belknap referred the Members to page 37 for review of the MEPA Environmental Monitor.

Ms. Belknap mentioned that the Environmental Committee met on June 4th and the minutes could be found on page 38. She stated at the meeting the Members focused on the new master DEP grant that she informed everyone about last month, that SRPEDD recently received to do watershed planning to address nitrogen and other pollutants in the Buzzards Bay watershed region. The committee also discussed the state's coastal programs, such as a new resilient Coast plan that the state has released that was open for comment. Ms. Belknap indicated the committee also decided to provide a letter of support to the Woods Hole Oceanographic Institute. She stated they are seeking grant funds from the Massachusetts Office of Coastal Zone Management for a Regional Coastal Monitoring Program. She mentioned they're looking to install loggers throughout Buzzards Bay and broader southeastern region to monitor sea level rise.

Chairwoman Clarner just wanted to added that dams were discussed as a management challenge in the region as well. Chairwoman Clarner asked if Ms. Belknap had received an answer about getting information about dams that are not controlled by municipalities. Ms. Belknap mentioned there is a layer in Mass GIS with dam safety ratings and other info. The Chairwoman stated that is what she was looking for.

Ms. Robbins mentioned the minutes from the Committee have not been approved by the committee therefore should not be vote on them yet, like the JTPG and MPO minutes. Mr. Walker concurred, stating that they would be brought back around for the full Commission's review and consideration once the Committee had had opportunity to meet again and approve them.

- c. Swansea Compton's Corner Stormwater Planning: Ms. Belknap and Ms. Matthews presented on the Swansea Compton's Stormwater Planning. Ms. Belknap stated the Swansea CZM Compton's Corner Project was a collaborative project with multiple partners: Town of Swansea, Save the Bay, SNEP Network, Coastal Zone Management, UMass Dartmouth SMAST program, Horsley-Witten, and New Bedford Public Health Lab. The goal of this project was to identify where and which contaminants are flowing from four stormwater drains in the Swansea Compton's Corner, a low-lying tidal point of drainage that flows into the Mt. Hope Bay and Lee's River. Our team identified which outfalls were creating the greatest amount of excess nutrients that were contributing to pollution in the Bay through multiple stormwater testing events. With this information, our team targeted the drainage areas corresponding to the highest polluting outfalls with opportunities for green infrastructure interventions. With our partners at Horsley Witten, we created a permit-ready green infrastructure and low impact nutrient absorbing design in one of the Town-owned parcels identified by the testing, and four other partial designs the Town of Swansea can pursue later with implementation money. Outreach events from the town helped inform us what locations residents of the neighborhood near Compton's Corner were preferred for future implementation.
- d. **Commissioner Orientation/Info Session- Wed, 7/9 at 6:30 pm via Zoom:** Mr. Walker mentioned the SRPEDD Commission Orientation/Info Session for new Commissioners will be held on Wednesday, July 9th at 6:30 PM via Zoom, with an agenda packet and detailed background information for new Members scheduled shortly to go out.

10. Old Business:

a. **Technical Assistance:** Mr. King referred Commissioners to the monthly update on projects contained in the packet on page 58. Mr. King mentioned that he and fellow staff are available to discuss projects as needed by email or calling the office.

A motioned was made and seconded to approve the Technical Assistance report. VOTED UNANIMOUSLY.

11. New Business: Mr. Whiten mentioned next week there is a public hearing at the State House before the Joint Committee on Environment and Natural Resources. The hearing can be attended either in person or via Zoom, and offer the opportunity, among other proposed legislation, for attendees to comment on Senate Bill 638 and House Bill 1000, which if passed, would establish a proposed wastewater financing committee for Southeast MA. Mr. Whitin stated that the bills outline a yearlong study process to help the communities on the south coast find alternate ways of financing wastewater improvements, and infrastructure. He indicated that Buzzards Bay and the estuaries in Buzzards Bay, including Westport, all the way to the Cape Cod Canal and on the Cape as well, are suffering from too much nitrogen load in the watersheds, and it is detrimental to the health of the estuaries. As envisioned, he stated there will be representative from each of the 14 communities affected, plus executive director of SRPEDD and others from the Joint Committee and different state agencies who would participate. Mr. Whitin mentioned that he would like a motion that the SRPEDD Commission support this legislation and if the Commission is in agreement for Mr. Walker to go and testify in favor of the bills. Mr. Hills asked if each out the towns will have representation. Mr. Whitin mentioned yes, each individual town that's affected by this would have a seat that is designated by their Select Board or City Council. Mr. Walker posted the information for the upcoming hearing in the Zoom chat and that Ms. Royer would be sending around additional information about the referenced bills.

A motion was made and seconded to direct the Executive Director, Jeff Walker to provide testimony on behalf of the referenced bills and establishment of the proposed wastewater financing committee at 20250723 SRPEDD Commission Mtg

the upcoming public hearing before the Joint Committee on Environment and Natural Resources with one abstention. VOTED UNANIMOUSLY.

- **12.** Roundtable: Opportunity for Commissioners to provide updates on local topics, projects or matters of regional interest: Mr. Desprez mentioned that the town of Plainville is excited about their project in the center of town with Jeff Kinney and what they have going on.
- **13. Adjourn**: The meeting was adjourned at 7:18 PM. The next meeting will be held on Wednesday, July 23, 2025, via Zoom at 6:30 PM.

SENATE No. 638

By Mr. Montigny, a petition (accompanied by resolve, Senate, No. 638) of Mark C. Montigny, Christopher M. Markey and Mark D. Sylvia that provisions be made for an investigation and study by a special commission (including members of the General Court) to establish a coastal waters wastewater financing commission. Environment and Natural Resources.

The Commonwealth of Alassachusetts

In the One Hundred and Ninety-Fourth General Court (2025-2026)

Resolve establishing a coastal waters wastewater financing commission.

1 Resolved, Notwithstanding any general or special law to the contrary, there shall be a

- special legislative commission to study and recommend specific revenue sources to fund
- 3 essential wastewater infrastructure improvements in response to nitrogen pollution in
- 4 southeastern Massachusetts near the Buzzards Bay watershed area specifically in the towns of
- 5 Acushnet, Carver, Dartmouth, Fairhaven, Lakeville, Gosnold, Marion, Mattapoisett,
- 6 Middleborough, New Bedford, Plymouth, Rochester, Wareham, and Westport.

7 The special legislative commission shall consist of 23 members and include the chairs of

8 the joint committee on environment and natural resources, who shall serve as co-chairs; the

secretary of the executive office of energy and environmental affairs or a designee; the secretary

of the executive office of administration and finance or a designee; the executive director of the

11 Southeastern Regional Planning and Economic Development District or a designee; the president

12 of the Buzzards Bay Coalition, Inc. or a designee; the executive director of the One Southcoast

Chamber, Inc. or a designee; 1 resident of the southeastern region to be appointed by the senate

president; 1 resident of the southeastern region to be appointed by the speaker of the house of representatives; and 1 person to be appointed by the select board or mayor of each of the 14 affected communities.

All appointees shall be made no later than 30 days following the effective date of this resolve. The co-chairs shall convene the first meeting of the special commission within 45 days of all appointments being made.

In the course of its deliberations, the commission shall make it a priority to examine the financial need of reducing nutrient pollution to the south coast's coastal waters including the costs to (i) expand sewer infrastructure to connect more septic systems to sewerage, (ii) expanding capacity and upgrading the level of treatment at existing wastewater treatment facilities (iii) constructing additional wastewater treatment facilities to address expanded service areas, (iv) reducing combined sewer overflow (CSO) discharges, and (v) upgrading septic systems to nitrogen reducing systems. Further, the commission shall examine (i) potential funding sources to finance wastewater infrastructure improvements and (ii) best practices for municipal financial policies and procedures.

The commission shall develop funding and financing recommendations to address wastewater infrastructure needs and to reduce nitrogen pollution in the southeastern region near the Buzzards Bay watershed area. The recommendations shall identify fair and equitable means of financing wastewater infrastructure improvements to address nitrogen pollution. The commission shall have the authority to work with outside experts to conduct necessary reviews; provide guidance on potential action plans; and provide economic analysis of financing sources. The experts shall be specialists in the fields of tax and revenue, nutrient pollution, water quality,

wastewater infrastructure, and any other fields that may be useful to implement the commission's tasks.

The commission shall hold not less than two public hearings in the southeastern region to assist in the collection and evaluation of data and testimony. Experts may attend the public hearings to provide testimony and any other relevant information regarding the fulfilment of the commission's objectives.

The commission shall prepare a written report detailing identified funding sources and its recommendations, if any, together with drafts of legislation necessary to carry those recommendations into effect. The commission shall submit its initial report to the governor, the secretary of the executive office of energy and environmental affairs, the clerks of the senate and house of representatives, the chairs of the house and senate committees on ways and means and the joint committee on environment and natural resources not later than 1 year after the effective date of this act.

Mattapoisett As executive director of the Southeastern Regional Planning and Economic Development District, or SRPEDD, based in Taunton, one of the Commonwealth's 13 regional planning agenies, enabled by the legislature back in 1968 to provide economic development, planning, and related technical assistance to the four Gateway Cities, 23 towns and 650,000 residents of growing southeastern Norton Mass, I am writing to share my organization's endorsement of bills **S638** and **H1000**, sponsored by Plainville Sen. Montigny and Rep. Markey, together with other honored members of our state delegation; Raynham Rehoboth and respectfully request your support.

Seekonk We are in favor of the bills and establishing a wastewater financing commission.

Somerset A significant portion of our diverse and vibrant region lies within the Buzzards Bay watershed, a Swansea critical resource for all of us, but one currently at risk, in particular, due to pollution, lack of funding, and other challenges faced by area communities and residents in instituting much-needed wastewater infrastructure improvements.

As envisioned by the drafters of S638 and H1000, the creation of a financing commission represents a timely, thoughtful, and promising first step.

Through its establishment and convening of area leaders and experts, the commission holds the capacity not only to identify and advance a range of possible funding sources and wastewater infrastructure improvement strategies, but also extend to communities a meaningful opportunity to participate and ensure that each of the referenced 14 towns are accorded equal voice and say. It also promises to help lay the foundation for innovative and cost-saving approaches of significant benefit to businesses, residents and local governments alike.

The anticipated costs to cash-strapped communities for necessary wastewater infrastructure improvements, indeed, are significant—projected at upwards of \$2B—and the establishment of a wastewater financing commission, we believe, is the prudent way forward.

For all of these reasons, on behalf of the SRPEDD Regional Commission, we extend our thanks again to both the sponsors and co-sponsors of S638 and H1000, and each of you on the Committee, for the bills' favorable advancement. We look forward to participating and contributing to the upcoming financing Commission's success.
